We commend him for his dedication.)

Shipmate President Rex Faubion called for the first Credentials Report.

Credentials Chair Anna Martin gave the Credentials Report and stated that there is a quorum present.

Shipmate President Rex Faubion stated that "you have heard he first credentials report. It has been moved and seconded to receive the report." A vote was held and the motion was carried.

Shipmate President Rex Faubion said they would proceed with our Officer Reports and gave his first: It has been an honor and privilege to serve as Northwest Region President. Starting this journey in 2022, it has been a pleasure to serve a second term as NW Regions' President.

During the past year I have had the opportunity to visit most of the CONUS Branches within the NW Region and found that a majority are still struggling with getting active participation from their membership. The members are on the rolls but choose not to participate. I've stressed the importance of communicating with all members, not just the few that show up at meetings.

Visits with CONUS Branches have been in person. Out CONUS Branches in Alaska, Japan and Guam have been contacts via phone and email. Contacts with Branches in the Philippines have been through email only.

This year has seen two Branches within the Region voluntarily surrender their charter: Branch 342, Anchorage, Alaska and Branch 068 Grants Pass, Oregon.

- Participated in LAFRA Zoom meeting to discuss future of LAFRA in NW Region.
- Attended NBOD meeting 24-27 April in Alexandria, Virginia.
- Northwest Region Mid-Year held via Zoom on 04 May 2024.

- Participated in Centennial of First Flight Around the World on 28 September 2024. Held in Magnuson Park, Seattle. Formerly Sand Point Naval Air Station which was the starting point for the First Flight in 1924.

Special Thank You to all the Gray Hats in the Region and Nationally that I have depended on for sound advice.

All funds received from the Fleet Reserve Association have been expended on FRA business.

Shipmate President Rex Faubion stated that "you have heard my annual report. It has been moved and seconded to receive the report." A vote was held and the motion was carried.

Shipmate President Rex Faubion said we will now hear the Vice President's Report.

Shipmate Vice President Robert S. Bean Sr, gave his report:

During this year I have primarily been a part of Branch 038. As part of Branch 038 there are two shipmates that are Regional Past Presidents. They have imparted knowledge upon me as to becoming the Regional President.

Shipmate Faubion has had a lot of trying times during his tenure, as did many Regional Presidents. I hope I can serve my time as President as well as he has.

I'm sure with the "Guidance" of the Past Presidents, as well as Shipmate Faubion's, my tour will be as successful as his.

This concludes my report, and I move that it be received.

Shipmate President Rex Faubion stated that "you have heard the Vice President's Report. It has been moved and seconded to receive this report." A vote was held and the motion was carried.

Shipmate President Rex Faubion said we will now hear the Regional Secretary/Treasurer's Report.

NW Regional Secretary/Treasurer Peg Burke presented her report:

This year we have PCT payments from all branches in our Region as August 30, 2024. We have continued to be successful with the new method of payment, i.e. remote electronic deposit via our Chase Bank App for those that send in their payments via email. This procedure is mainly used by our Pacific Branches to pay their dues versus using "snail mail".

Each Branch President, Secretary, and Treasurer, if the Branch has the position separated, in the Region is sent an email with their PCT letter attached informing them of the amount of PCT dues to be paid to the Region. We will only use USPS (snail mail) when a Branch has no one with an email address for us to use.

The Edward Jones Investment is still crawling back up after we lost a few dollars during the first year. It is slowly getting back to our original investment of \$10,000. We are less than \$200 away. The Northwest Region has as of July 31, 2024, the following in funds:

Checking: \$6,908.28 Savings: \$5,847.88

Certificate of Deposit (CD) \$10,064.15

On June 8, 2024, the CD matured and we earned \$380.83 in interest on the CD which we deposited to the NWR Savings Account. We rolled over the original \$10,000 into another CD with a 9-month maturity date of 3/8/2025. The interest rate on this 9-month CD is 4.25% APY.

Edward Jones Investments \$9,803.05

A loss of \$196.95 since established.

Note: At the end of August 2024, the bank statement came in for this account and we are now above our original investment amount of \$10,000. We are earning money now.

Total in bank accounts: \$32,623.36

Note: Of the \$32,623.36, please note that **\$4,721.09** is for Essay Contest funds. That gives us **\$27,902.27** in our operating cash fund.

This concludes my report, and I move that it be received.

Shipmate President Rex Faubion asked the Northwest Regional Chaplain Bill Hall to open the Bible.

Shipmate President Rex Faubion called for the second Credentials Report.

Credentials Chair Anna Martin stated there were no changes to the Credentials Report.

NW Region Budget Committee Chair PRPNW Flanik gave his report. The Audit of the Northwest Region Financials was completed September 5, 2024, and found to be in order.

Shipmate President Rex Faubion stated that "you have heard the Budget, Finance, and Audit Report. It has been moved and seconded to receive the report." A vote was held and the motion was carried.

NW Region Veterans Services Committee Chair PRPNW Tom Flanik submitted the following report for branches.

Branch 063 seems to have found the way to get the information out to the students. Well done. National awards have been extremely slow in the process this year. Winners at the National level are required to submit paperwork for tax purposes before any monetary award can be presented. We still have one student, a 2nd place at the 12th grade level, that has not responded to requests for the tax information. Consequently, no check will be processed until the paperwork is completed.

NW Region Membership & Retention Committee

Currently, the Fleet Reserve Association has a total of 26,539 members and Members-at-Large. Fifteen (15) months ago we were at 29,401 members and Members-at-Large. In 15 months, we lost 3,042 members, or 203 members per month. That is why we are having such a push to get new members.

Currently all of the servicemen's groups are having a problem recruiting new members. We need to come up with a better way to get more members to join our group. We are limited to who can join, in that we are for the Sea Services. There are so many areas that are not explored, Montana has none, Wyoming has a Branch, North Dakota has one, South Dakotas has none.

We have ways to have Branches, or at least people via Zoom Meetings, as well as Microsoft Teams, and many others.

The Northwest Region did have a nominee for the Frank J. McPherson Memorial Award that will be forwarded to the FRA National Membership Committee for consideration. Their nominee is PRPNW Margret "Peg" Burke.

NW Region Legislative Chair, Jerry Fugich Report is as follows:

This year was again successful for veterans related bills considering this was a non-budget year. The Veterans Legislative Coalition was able to get 12 Veterans related bills passed that will help Active-duty military families, Retired Veterans and widows of veterans.

On September 28, 2024, there will be a celebration for the Centennial Celebration for the First Flight Around the World by the Army Air Services at Magnuson Park (the old Sand Point Naval Air Station) because of a Washington State House Resolution funding was made available for this very special celebration. There will also be an FRA recruiting offer available at this event.

Legislatures from other states have noticed the things that the Veterans Legislative Coalition (VLC) has been doing for veterans. A few months back US Senator Rounds of South Dakota ask the VLC for our support to establish a Native American Indian Veteran Service Organization. There was a US Congressional Charter passed by the US Senate that has established the Native American Indian Veterans Organization "NAVI".

Many of us belong to more that on Veterans Service Organization the Disabled American Veterans continually request support for US Bills that will help or Disabled Veteran Comrades in the last 5 months I have sent 8 letters to help our Comrades if you get these letters/e-mails please take the time to respond.

Would really like to see some form of Veterans Legislative Coalition organizations in other states in your FRA region. The FRA could show the leadership in other states and territories in your region to make this happen.
